Legal Description of District Boundaries

- 1) A Tract of land being part of Tract B, FORT LUPTON COMMUNITY CENTER SUBDIVISION, a subdivision of land in the City of Fort Lupton, Weld County, Colorado and lying in the Southwest quarter of Section 5, Township 1 North, Range 66 West of the Sixth Principal Meridian, the plat of said subdivision recorded as Reception Number 2766474, said Tract more particularly described as follows:

Commencing at the Southwest corner of said Section 5 monumented by a found 3-1/4 inch aluminum cap marked "PLS 13155", from which the South Quarter-Corner of said Section 5 monumented by 3-1/4 inch aluminum cap marked "PLS 13155" bears North 89° 40' 33" East a ground distance of 2631.61 feet; and all bearings herein are relative thereto; Thence North 89° 40' 33" East 835.49 feet on the South line of said Southwest Quarter; Thence North 00° 43' 28" West 662.79 feet to a 3/4 inch metal rod found at a corner on the westerly line of said Tract B; Thence North 00° 39' 34" West 190.92 feet on said westerly line to the POINT OF BEGINNING; Thence continuing North 00° 39' 34" West 190.92 feet on said westerly line to the Southwest corner of Lot 1, FORT LUPTON COMMUNITY CENTER SUBDIVISION SECOND AMENDMENT, a subdivision of land in said city, county and state, the plat of said subdivision recorded as Reception Number 4380390; Thence North 89° 38' 16" East 365.85 feet on the South line of said Lot 1 to a 2 inch aluminum cap marked "PLS 37971" found at the Southeast corner of said Lot 1; Thence South 00° 42' 20" East 191.24 feet; Then South 89° 41' 15" West 366.01 feet to the POINT OF BEGINNING; said Tract containing 69,922 square feet or 1.605 acres.

- 4) A parcel of land being a portion of that parcel of land described in Warranty Deed recorded August 13, 1974 at Reception No. 1642661 within the records of the Weld County Clerk and Recorder and being a portion of the West Half of the Southwest Quarter(W1/2SW1/4) of Section Five(5), Township One North (T.1N.), Range Sixty-six West (R.66W.) of the Sixth Principal Meridian (6thP.M.), City of Fort Lupton, County of Weld, State of Colorado, being more particularly described as follows;

COMMENCING at the Southwest corner of Section 5 and assuming the South line of the SW1/4 of said Section 5 as monumented by a #6 rebar at the West end and by a #6 rebar with an illegible 2.5" aluminum cap at the East end, as bearing North 89°40'24" East, being a grid bearing of the Colorado State Plane Coordinate System, North Zone, North American Datum 1983, a distance of 2631.31 feet, with all other bearings contained herein being relative thereto.

The lineal dimensions as contained herein are based upon the "U.S. Survey Foot."

THENCE North 00°30'45" West along the West line of the SW1/4 of Section 5 a distance of 225.00 feet to the **POINT OF BEGINNING**;

THENCE continuing North 00°30'45" West along said West line a distance of 1050.86 feet;

THENCE North 89°38'25" East a distance of 155.05 feet;

THENCE North 00°18'46" West a distance of 99.99 feet;

THENCE North 89°39'07" East a distance of 274.91 feet to the Westerly right-of-way line of the Union Pacific Railroad;

THENCE South 00°42'16" East along said Westerly right-of-way line a distance of 1151.07 feet;

THENCE South 89°40'24" West a distance of 434.16 feet to the West line of the SW1/4 of said Section 5 and to the **POINT OF BEGINNING**.

Said parcel of land contains 11.06 Acres (+/-481,961 sq.ft.) and is subject to any rights-of-way or other easements of record as now existing on said described parcel of land.
